To consider moving forward with Real Term Energy for a full inventory of street lights

The Town Manager explained that the next step in moving forward with this project is to have Real Term Energy come to our town to do a complete inventory of our street lights. During this inventory they would determine how many street lights we have,

what strength bulbs are being used, are there street lights that exist for nothing, can we put a stronger bulb in one street light to maybe eliminate another light, are we paying the wrong amount for our existing street lights based on the wrong recorded wattage from Emera, and so on. This inventory would cost \$35 per light. We have 60 street lights so the cost would be \$2100. This amount was budgeted for in FY18 and will be budgeted again in FY19 incase the inventory doesn't happen before June. We would get all the previous information, GPS data, a proposal for the switch to LED, financing options, and an average savings projection per month that we would see after the switch. Real Term will only come to our area to do the inventory if enough communities are involved.

By a consensus vote the Board agreed to move forward with the inventory.
