Article 5: To discuss retaining wall demolition options at boat landing

Andrew Dube CEO was in attendance. Andrew explained that we cannot create a beach. He also explained that if we remove the retaining wall we need to replace it or put rip rap in its place. It was decided that Andrew will apply for a permit by rule from the department of environmental protection to remove the retaining wall, replace it with rip rap, remove the large shrub and replace it with a tree, add a 4ft stair case down to

the water and lake rake a 10-foot section.

Article 6: To discuss sewer options for property located at map 13 lot 38E

This property belongs to Jason Bouchard. Jason will be building a house this year and was questioning if he needed to hook up to Town sewer. There were a few questions discussed at the meeting. How far a structure has to be from the sewer to be able to put in their own private system? Can three houses share a pump station? Would he have to cross the road? Does the Town cover the cost of a new pump station for a new user? Most of these questions can be answered by reading the sewer ordinance. The Town Manager will read the ordinance and sewer plan maps and report back to the board.
