A notice to all residents and friends of Saint Agatha:

We will be implementing the following measures in an effort to combat the spread of COVID-19 effective immediately.

Long Lake Regional Wellness Center:

The Fitness Center **will be closed for a period of at least two weeks as of 8:00am Wednesday March 18th, 2020 till April 1st, 2020.** After this two-week period the Board of Selectmen will meet to re-evaluate the risk of spread and make their decision to re-open or remain closed for an additional period of time. During this time, a full spring cleaning will be done to the fitness center and equipment in an effort to make sure everything is sterilized. Town Office staff will also adjust every active Fitness Center member to extend their expiration dates by two weeks. Should Fitness Center members need to collect any belongings they must do so by contacting the Town Office to allow entry by no later than March 23.

Public Works Garage:

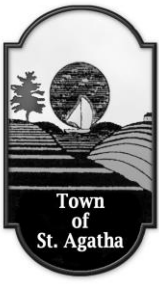
